

Privacy Policy for CreatorBid

1. Introduction

This Privacy Policy describes how CreatorBid, owned and operated by Lime Tree Labs Inc., a BVI Corporation (“we,” “us,” or “our”) collects, uses, and discloses personal information when you access and use our platform, website, and services (collectively, the “Platform”). By using the Platform, you agree to the collection and use of your personal information in accordance with this Privacy Policy.

We value your privacy and are committed to protecting your personal data. This Privacy Policy explains:

- What information we collect.
- How we use your information.
- How we protect your information.
- Your rights and choices regarding your personal data.

2. Information We Collect

We collect different types of information depending on how you interact with the Platform:

a. Information You Provide to Us

- **Account Information:** When you create an account on the Platform, we collect your name, email address, and any other information you provide during the registration process.
- **Communications:** If you contact us for support or other inquiries, we may collect any information you voluntarily provide.

b. Information We Collect Automatically

- **Usage Data:** We collect information about your activity on the Platform, including IP address, browser type, pages visited, and time spent on pages.
- **Device Data:** We may collect information about the device you use to access the Platform, such as device type, operating system, and device identifiers.

c. Non-Personal Information

In some cases, we may collect information that is not personally identifiable. This could include anonymized data or aggregated information.

d. Blockchain Data

Since CreatorBid operates as a non-custodial platform, certain transaction data related to your interaction with digital assets (such as tokens) may be visible on public blockchain networks. This data may include wallet addresses and transaction amounts but is not controlled by CreatorBid.

3. How We Use Your Information

We use the information we collect to:

- **Provide and Improve the Platform:** We use your personal information to operate, maintain, and enhance your experience on the Platform.
- **Communicate with You:** We may send you service-related communications (such as account verification, updates, and technical notices) and respond to your inquiries.
- **Ensure Security:** We use your data to protect the integrity of the Platform and detect and prevent fraud, abuse, and illegal activities.
- **Comply with Legal Obligations:** We may process your information to comply with applicable legal obligations, such as responding to requests from law enforcement or complying with regulatory requirements.

4. Sharing Your Information

We do not sell or rent your personal information. However, we may share your information with trusted third parties in the following situations:

a. Service Providers

We may share personal information with third-party service providers who assist us in operating the Platform (e.g., hosting providers, analytics services). These service providers are bound by confidentiality agreements and may only use your information as instructed by CreatorBid.

b. Legal Requirements

We may disclose your personal information if required by law or in response to a valid legal request (such as a subpoena or court order).

c. Business Transfers

In the event of a merger, acquisition, or sale of all or a portion of our business, your information may be transferred as part of the transaction.

5. Cookies and Tracking Technologies

We use cookies and similar tracking technologies to enhance your experience on the Platform. These technologies may collect information about your device and usage patterns. You can control cookie preferences through your browser settings, but disabling cookies may limit some features of the Platform.

6. Data Security

We take reasonable measures to protect your personal information from unauthorized access, disclosure, alteration, or destruction. These measures include encryption, secure servers, and access control protocols. However, no data transmission over the internet or storage system can be guaranteed as completely secure.

Blockchain Data Security

As CreatorBid operates on decentralized networks, certain aspects of your interactions with the Platform, such as transactions conducted via blockchain, may be outside of our control and visible to the public. We cannot control the security of information shared on these networks.

7. Your Rights and Choices

Depending on your location, you may have the following rights regarding your personal information:

- **Access:** You have the right to request a copy of the personal information we hold about you.

- **Correction:** You have the right to request that we correct any inaccuracies in your personal information.
- **Deletion:** You may request that we delete your personal information, subject to certain exceptions.
- **Data Portability:** In certain situations, you may have the right to request that we transfer your personal information to another party.
- **Opt-Out of Communications:** You may opt-out of receiving promotional communications from us by following the unsubscribe instructions included in the emails or by contacting us directly.

We retain personal information for as long as necessary to fulfill the purposes outlined in this Privacy Policy, unless a longer retention period is required or permitted by law. We may also retain and use your data as necessary to comply with legal obligations, resolve disputes, and enforce our agreements.

9. International Data Transfers

CreatorBid is based in British Virgin Island. If you are accessing the Platform from outside this location, your personal information may be transferred to, and processed in, a jurisdiction that may not offer the same level of data protection as your home jurisdiction. By using the Platform, you consent to the transfer of your personal information to such jurisdictions.

10. Children's Privacy

The Platform is not intended for use by individuals under the age of 18. We do not knowingly collect personal information from children under 18. If we become aware that we have inadvertently collected information from a child under 18, we will take steps to delete that information.

11. Changes to This Privacy Policy

We may update this Privacy Policy from time to time. If we make material changes, we will notify you by posting the updated policy on the Platform or by other appropriate means. Your continued use of the Platform following the posting of changes constitutes your acceptance of those changes.

- The right to restrict or object to the processing of your personal information.

You can opt-out of receiving marketing or promotional communications at any time by following the instructions included in the communications. Please note that you may still receive essential service-related communications even after opting out of marketing messages.

In compliance with the Children's Online Privacy Protection Act (COPPA), if we become aware that we have collected personal information from a child under the age of 13, we will take steps to delete that information as quickly as possible.

15. Blockchain and Personal Data

Due to the decentralized nature of blockchain technology, certain data (e.g., wallet addresses, transaction information) is permanently recorded on public ledgers. CreatorBid has no control over the removal or alteration of this information once it has been recorded. Users should carefully consider the implications of interacting with blockchain-based services.
